

Terms and conditions

Below is an abbreviated version of the Terms and Conditions for the issuing of Tickets to the London 2012 Olympic Games opening ceremony technical rehearsal ("Terms and Conditions"), which are available on the website www.london2012.com/tr. All capitalised words have the meaning set out in the Terms and Conditions and reading the below is not a substitute for reading the full Terms and Conditions. By accepting, holding or using a Ticket, you acknowledge that you have read, understood and accepted the full Terms and Conditions.

This Ticket grants you a right of entry to a Venue to attend and to occupy a space or seat at a Session. You should keep your Ticket with you at all times. Tickets shall remain the property of LOCOG. If you leave a Venue for any reason, you may not re-enter. There will be no pass-outs or re-admissions of any kind.

Save as expressly authorised by the London Organising Committee of the Olympic Games and Paralympic Games Limited ("LOCOG"), Tickets are **STRICTLY NON-TRANSFERABLE** and **MUST NOT BE SOLD** (including by way of auction) nor advertised for sale. Tickets may not be used for advertising, promotion, fundraising or marketing purposes (including in competitions, contests and sweepstakes) unless authorised by LOCOG.

Tickets obtained from Persons other than directly from LOCOG or an ATD shall be VOID and may be SEIZED or CANCELLED WITHOUT REFUND OR ENTRY TO A SESSION. Any Person seeking to use a Ticket obtained in breach of the Terms and Conditions may be considered a trespasser, may be ejected and may face legal action. Tickets are issued free of charge. In the event that Sessions are delayed, interrupted, shortened, rescheduled, postponed or cancelled (i.e. not held at all) there will, therefore, be no compensation offered or exchanges of Tickets for another Session.

You accept the risks and dangers of attending a Session. You are responsible for your personal property and your own safety and for the safety of any accompanying children or vulnerable persons. You release LOCOG, ATDs, Venue owners and the Games Bodies from any liability for any loss or damage to personal property you may suffer in relation to your attendance at a Venue. Except as required by law, none of LOCOG, the ATDs, any Games Bodies or any other Person involved in the organisation of the Games shall have any liability to a Ticket Holder.

You have read LOCOG's Spectator Policy and understand the list of prohibited and restricted items that may not be brought into a Venue and the list of forbidden behaviour. You agree to being photographed, filmed or recorded by LOCOG, the IOC, or third parties authorised by them. LOCOG, the IOC, or third parties authorised by them shall, without payment, have the right to broadcast, publish, license and use any such photographs, films or recordings of you in perpetuity.

You acknowledge that your Ticket provides you with privileged access to the technical rehearsal for a major global event and that the content of the rehearsal is confidential. The taking, by any means, of still images, video and sound recordings of the performances by you is, therefore, strictly prohibited. You agree that you may be subject to security searches in order to ensure safety at a Session.

Unauthorised resale of this ticket may result in criminal prosecution.

- Unlawful resale (or attempted) is grounds for seizure or cancellation without refund or compensation.
